ORDINANCE NO. 2017-13-04

AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF LOCAL TAXES,  
FEES AND CHARGES WITHOUT PENALTIES AND SURCHARGES FROM JANUARY 20,  
2017 TO FEBRUARY 28, 2017

Sponsor: Hon. Jerry S. Uy

WHEREAS, Section 167 of the Local Government Code of 1991, *vis-a-vis* Section 151 of the Tacloban City Revenue Code, allows the Sanggunian for a justifiable reason or cause, to extend the time for payment of local business taxes, licenses, fees or charges without surcharges or penalties, as the case may be, but not to exceed six (6) months from January 20

Be it enacted by the Sangguniang Panlungsod, City of Tacloban, Philippines, that:

Section 1. **PERIOD OF EXTENSION.** - The deadline for the payment of local taxes, fees and charges without penalties and surcharges is hereby extended from January 20, 2017 to February 28, 2017. Should there be any penalty or surcharge collected after January 20, 2017, before the enactment of this Ordinance, the same shall be credited for the next quarter or year, as the case may be

Section 2. **DISSEMINATION OF INFORMATION.** - Let a copy of this Ordinance be furnished the Office of the City Treasurer, Accounting Department, City Administrator, Business Permits and Licensing Division, other concerned offices and general public, for their information and guidance

Section 3. **EFFECTIVITY.** - This Ordinance shall take effect immediately upon its approval.
