ROMUALDEZ, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE FIRST CONGRESSIONAL DISTRICT OF LEYTE, THE DEPARTMENT OF TRADE AND INDUSTRY-RO8, DEPARTMENT OF SCIENCE AND TECHNOLOGY-RO8, DEPARTMENT OF TOURISM-RO8, DEPARTMENT AGRICULTURE-RO8, AND THE TACLOBAN NATIVE DELICACIES AND HANDICRAFT PRODUCERS ASSOCIATION, RELATIVE TO THE PROJECT CALLED “PRODUCT 8” A SHOWROOM OR HUB FOR THE LOCAL PRODUCERS TO MARKET AND SHOWCASE THEIR PRODUCTS ON A CONSIGNMENT BASIS**
