COMMITTEE REPORT

On February 14, 2017 at 3:00 o'clock in the afternoon at the Sangguniang Pantungod Session Hall, Tacloban City, the Committee on Ways and Means deliberated at the committee level the Proposed Ordinance entitled "AN ORDINANCE ENACTING THE REVISED TACLOBAN CITY INVESTMENT AND INCENTIVES CODE OF 2017"

The hearing was presided by Atty. Jerry Uy, Chairman of the Committee on Ways and Means, and attended by members of the committee, Hon. Raissa J. Villasin, Vice Chairperson, Hon. Evangelina Esperas and Hon. Jose Mario Bagulaya.

Mr. Richard Estrada, representing Hon. Elvira Casal, Mr. Jan Ray I. Verona, representing Hon. Amara Graffi, were also present. Mrs. Zosima Cerdano, City Treasurer of Tacloban and Atty. Euenaventura Go-coto, City Consultant, acted as resource persons.

The Committee together with the resource persons agreed that there is a need to enact a Revised Investment Code for the City in order to invite investors, both local and international, to invest in the City, particularly in the Northern Barangays which need attention in order to create jobs and employment for the internally displaced persons affected by the Super typhoon Yolanda.


