Invitation to Bid for the CONSTRUCTION OF FLOOD CONTROL PROJECT WITH EASEMENT PHASE II AT TACLOBAN NORTH MARKET TO GMA KAPUSO VILLAGE, TACLOBAN CITY


1. The **City Government of Tacloban**, through the **20% Development Fund, Current Appropriation** intends to apply the sum of **Php19,982,556.59** being the Approved Budget for the Contract (ABC) to payments under the contract for the **CONSTRUCTION OF FLOOD CONTROL PROJECT WITH EASEMENT PHASE II AT TACLOBAN NORTH MARKET TO GMA KAPUSO VILLAGE, TACLOBAN CITY/POW #023-2023**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **City Government of Tacloban** now invites bids for the above Procurement Project. Completion of the Works is required within **Two Hundred Ten (210) Calendar Day/s**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the **City Government of Tacloban** and inspect the Bidding Documents at the address given below from **9:00 am to 3:00 pm, Mondays to Fridays, except on holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **May 2, 2023 to May 23, 2023** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of [Php25,000.00]*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **in person**.

6. The **City Government of Tacloban** will hold a Pre-Bid Conference¹ on **02:00 PM of May 9, 2023** at *BAC Office, 4th Floor City Hall New Building, Kanhuraw Hill, Tacloban City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **10:00 AM of May 23, 2023**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **02:00 PM of May 23, 2023** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **City Government of Tacloban** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
