**INVITATION TO BID FOR THE
Procurement of MEDICAL SUPPLIES AND LABORATORY
INSTRUMENTS – 2 LOTS**

1. The *City Government of Tacloban*, through the *General Fund 2024* intends to apply the sum of *One Million Fifty-Five Thousand Two Hundred Pesos and 00/100 (Php1,055,200.00)* being the total ABC to payments under the contract for the *Procurement of MEDICAL SUPPLIES AND LABORATORY INSTRUMENTS – 2 Lots/ REF #035-05-2024*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *City Government of Tacloban*, through the *General Fund 2024* intends to apply the sum of *Seven Hundred Sixty-Four Thousand Nine Hundred Pesos and 00/100 (Php764,900.00)* for *Procurement of MEDICAL SUPPLIES AND LABORATORY INSTRUMENTS -Lot 1, PR No. 223041279 and Two Hundred Ninety Thousand Three Hundred Pesos and 00/100 (Php290,300.00)* for *Procurement of MEDICAL SUPPLIES AND LABORATORY INSTRUMENTS -Lot 2, PR No. 223041282* being the ABC to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *City Government of Tacloban* now invites bids for the above Procurement Project. Delivery of the Goods is required by within *Thirty (30) Day/s*. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from The *City Government of Tacloban* and inspect the Bidding Documents at the address given below during *9:00 am to 3:00 pm, Mondays to Fridays, except on holidays*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *May 21, 2024 to June 11, 2024* from the given address and website(s) below *in the amount*

provided in the table below. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.


[NOTE: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.]

6. The *City Government of Tacloban* will hold a Pre-Bid Conference¹ on **02:00 PM of May 28, 2024** at *BAC Office Conference Room, BAC Office, 4th Floor City Hall New Building, Kanhuraw Hill, Tacloban City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **10:00 AM of June 11, 2024**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **02:00 PM of June 11, 2024** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *City Government of Tacloban* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
