A complete set of Bidding Documents may be acquired by interested bidders on **September 3, 2024 to September 24, 2024** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of [Php1,000.00]. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

- 6. The *City Government of Tacloban* will hold a Pre-Bid Conference<sup>1</sup> on **02:00 PM of September 10, 2024** at *BAC Office, 4<sup>th</sup> Floor City Hall New Building, Kanhuraw Hill, Tacloban City,* which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 10:00 AM of September 24, 2024. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on **02:00 PM of September 24, 2024** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *City Government of Tacloban* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
