- 6. The City Government of Tacloban will hold a Pre-Bid Conference¹ on 02:00 PM of February 4, 2025 at BAC Office, 4th Floor City Hall New Building, Kanhuraw Hill, Tacloban City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 10:00 AM of February 18, 2025. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on **02:00 PM of February 18, 2025** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
