**INVITATION TO BID FOR THE
 PROCUREMENT OF CONSTRUCTION
 MATERIALS AND SUPPLIES**

1. The *City Government of Tacloban*, through the *General Fund 2025* intends to apply the sum of *Four Million Nine Hundred Ninety-Nine Thousand Nine Hundred Eighty-Seven Pesos and 00/100 (Php4,999,987.00)* being the total ABC to payments under the contract for the **PROCUREMENT OF CONSTRUCTION MATERIALS AND SUPPLIES/REF #019-04-2025**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *City Government of Tacloban* now invites bids for the above Procurement Project. Delivery of the Goods is required by within *Three (3) Month/s*. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from The *City Government of Tacloban* and inspect the Bidding Documents at the address given below during *9:00 am to 3:00 pm, Mondays to Fridays, except on holidays*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *April 15, 2025 to May 6, 2025* from the given address and website(s) below *in the amount of Php5,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The *City Government of Tacloban* will hold a Pre-Bid Conference¹ on **02:00 PM of April 22, 2025** at *BAC Office Conference Room, BAC Office, 4th Floor City Hall New Building, Kanhuraw Hill, Tacloban City*, which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference

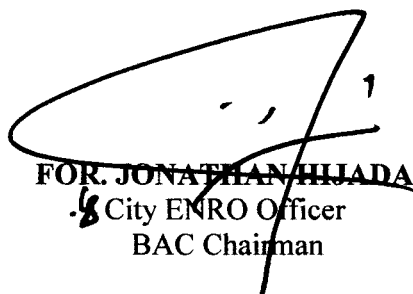
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **10:00 AM of May 6, 2025**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **02:00 PM of May 6, 2025** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **City Government of Tacloban** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
