To wit:

Bidders should have completed within five (5) years from the date of submission and receipt of bids a contract similar to the project.

 - (b) Valid Mayor's Permit;
 - (c) List of projects for the last two years (ongoing government and private contracts);
 - (d) Bid security issued in favor of the City Government of Tacloban shall be either in the following forms and amount:
 - (i) 2% of the ABC, if cash or cashier's/manager's check, bank draft/guarantee, or irrevocable letter of credit issued by a Universal or Commercial bank;

- (ii) 5% of the ABC, if surety bond with certification from Insurance Commission that such insurance company is authorized to issue such security;
- (iii) Any combination of the foregoing; and/or
- (iv) Bid Securing Declaration. Sample form is attached as (Annex D).
- (e) Compliance with the Scope of Works (Annex A), Bid Data Sheet (Annex B) Cash Flow and Payment Schedule, Detailed Estimates and Original of the duly signed and accomplished financial bid form and Bill of Quantities (Annex C);
- (f) Omnibus Sworn Statement;
- (g) Audited Financial Statement (Latest Income Tax Returns);
- (h) PCAB License
- (i) Duly signed Organizational Chart for the contract to bid;
- (j) Duly signed list of Contractor's Key Personnel (Project Manager, Project Engineer, Materials Engineer, Foreman)
- (k) Duly signed list of Contractor's Equipment (owned, leased, or under purchase agreement)
- (l) Authority of the Signatory; and
- (m) Certification of Philgeps Registration: Platinum Membership
- (n) Computation of its Net Financial Contracting Capacity
- (o) SLCC similar to the contract to be bid
- (p) Updated Tax Clearance Certificate
- 3. Opening of the eligibility documents, technical documents, and financial proposal will be on **02:00 PM of July 3, 2025.**
- 4. A complete set of Bidding Documents may be acquired by interested bidders on **June 24**, **2025**, to **July 3**, **2025**, from the given address.
