- 3. The City Government of Tacloban now invites bids for the above Procurement Project. Completion of the Works is required within One Hundred Twenty-Two (122) Calendar Day/s. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).
- 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the IRR of RA No. 12009 or the NGPA.
- 5. Interested bidders may obtain further information from the BAC Office, City Government of Tacloban and inspect the Bidding Documents at the address given below from 9:00 am to 3:00 pm, Mondays to Fridays, except on holidays.
- 6. A complete set of Bidding Documents may be acquired by interested bidders from May 22, 2025 to June 10, 2025 from the given address and website/s below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of [Php5,000.00]. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 7. The *City Government of Tacloban* will hold a Pre-Bid Conference<sup>1</sup> at **02:00 PM** on **May 29, 2025,** at the *BAC Office, 4<sup>th</sup> Floor City Hall New Building, Kanhuraw Hill, Tacloban City,* which shall be open to prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 10:00 AM on June 10, 2025. Late bids shall not be accepted.
- 9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Section 56 of the IRR of RA 12009.
- 10. Bid opening shall be at **02:00 PM on June 10, 2025**, at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
