Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from The City Government of Tacloban and inspect the Bidding Documents at the address given below during 9:00 am to 3:00 pm, Mondays to Fridays, except on holidays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on May 29, 2025 to June 17, 2025 from the given address and website(s) below in the amount of Php5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- The City Government of Tacloban will hold a Pre-Bid Conference on 02:00 PM of June 6. 5, 2025 at BAC Office Conference Room, BAC Office, 4th Floor City Hall New Building, Kanhuraw Hill, Tacloban City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 10:00 AM of June 17, 2025. Late bids shall not be accepted.
